Medical Colleges in their respective States to send the information with regard to availability of Professors in the subjects of broad specialities and availability of Professors & Associate Professors in respect of Super-specialities and also Unit wise number of existing beds & students. The information received from your college was considered by the Postgraduate Committee of Medical Council of India at its meeting held on 11/11/2009 in its 10<sup>th</sup> meeting in Gazette Notification dated 24/7/2009 and is now referred to this Ministry for issue of permission for enhancement of seats in various post graduate courses.
